

The Terms and Conditions of "Spend & WIN" HSBC Credit Card Promotion

- The "Spend & Win" Promotion (hereinafter referred to as the "Promotion") of The Hongkong and Shanghai Banking Corporation Limited, Sri Lanka Branch (hereinafter referred to as "HSBC/ Bank") is open to all holders of valid HSBC credit cards issued locally (hereinafter referred to as "Credit Card"), excluding all HSBC corporate credit cardholders and staff members of HSBC (hereinafter referred to as "Cardholders").
- 2. The Promotion shall be effective from 20 November 2024 to 31 December 2024, inclusive of both days (hereinafter referred to as the "Promotional Period").
- 3. Cardholders can register to participate in this Promotion till 31 December 2024 by sending a SMS typing "iWIN" to 4774 from their mobile number registered with the Bank HSBC. A confirmation SMS will be sent to the Cardholder upon successful registration and winners will be selected only from the registered base.
- 4. During the Promotional Period Cardholders can swipe the Credit Card to perform any of the below transactions, excluding transactions referred in clause 7 below and earn points as follows (hereinafter referred to as "Points")

- 6. The following transactions shall not be considered under eligible transactions for the Promotion to earn points.
 - i. Fees and Charges as per Bank's Tariff and Charges and applicable tax.
 - ii. Quasi transactions such as, but not limited to, Casino or Gambling transactions performed locally, overseas, or online and crypto currency transactions.
 - iii. Overseas Cash advances
- 7. Transactions from both primary and supplementary HSBC credit cards shall be accumulated and the primary Cardholders will be eligible for the prize as referred in point 5.
- 8. The winners will be selected based on HSBC system records and only transactions posted in HSBC system on or before 15 January 2025 will be considered, and such decision shall be final and conclusive.
