"HSBC International Student proposition" Promotion - TERMS AND CONDITIONS

- a. The Student should fulfill the criteria specified in the application form and complete the same which includes a write up of 350 words stating the purpose of their application for the scholarship and their future plans,
- b. The Student has to furnish names of 2 persons who are aware of their background, achievement and contribution to the society.
- 4. Staff members of the Bank and of the HSBC Group Service Centre in Sri Lanka shall be excluded from the Promotion.
- 5. Awarding of the HSBC scholarship,
 - 5.1 The completed application forms will be reviewed by an independent group consisting of two heads from leading international schools and a representative from HSBC. One winner will be selected.
 - 5.2 The successful Students will receive the funds equivalent to USD10,000/- at the prevailing exchange rate in LKR to their Student File nominated account. This will be for the sole purpose of payment of University Fees. Therefore the funds will be on hold until a written request with supporting documents are received from the parent/Student for the fund transfer to the University.
