IMPORTANT NOTICE

In keeping with Central Bank of Sri Lanka (CBSL) guidelines all Banks have been instructed not to accept any willfully mutilated, altered or defaced currency notes with effect from 1 April 2018. CBSL will exchange such notes on behalf of the general public after 1 April 2018.

In our efforts to adhere to this requirement, please note that any such currency notes deposited after **1 May 2018** will be deducted from the total value of the deposit and the physical currency notes will be held at the branch where the deposit was made. For any payments made at non branch deposit machines, notes can be collected from our Union Place branch.

HSBC Credit cardholders are bound by the current tariff issued by the bank for any fees/charges accrued and the bank shall not be held responsible for any losses/damages accrued due to this reason.

Notice to the public by the Central Bank of Sri Lanka !

From 31st March 2018 until further notice, the currency notes which have been wilfully mutilated can be exchanged for clean currency notes from the head office of the Central Bank of Sri Lanka or by sending to the head office through regional offices or by registered post.

The relevant form for this service can be obtained from the Central Bank of Sri Lanka web site (www.csl.gov.lk) or regional office or from any branch of licensed Commercial Bank.



However, the currency notes have been mistakenly marked in the form of a small dot or a line are not considered as wilfully mutilated currency notes and such currency notes can be further used for transactions.
