

## Terms and Conditions

1. The “Premier Bonus Rewards” promotion (hereinafter referred to as the “Promotion”) of The Hongkong and Shanghai Banking Corporation Limited (hereinafter referred to as “HSBC”/“Bank”) is open to all HSBC Premier MasterCard Credit Cardholders of HSBC, holding a valid Credit Card issued in Sri Lanka, excluding all staff members of HSBC (hereinafter referred to as “Credit Card / Cardholders”).
2. The Promotional period shall be effective from 01<sup>st</sup> November 2020 to 02<sup>nd</sup> January 2021, inclusive of both days (hereinafter referred to as the “Promotional Period”).
3. The Cardholder with the highest spend for the week (from Sunday to Saturday), excluding transactions referred in clause 10 below, during the Promotional Period will receive 100,000 bonus HSBC rewards points weekly.

4. A Cardholder can earn bonus HSBC rewards points only once during the Promotional Period.
5. In order to be eligible for the Promotion the Cardholder must spend a minimum of LKR 1,000,000/- using the Credit Card within a specified week as set out in clause 3 above.
6. The bonus HSBC reward points will be added to the primary Cardholder's Credit Card account within 30 bank working days from the Promotional Period end date.
7. The Cardholder cannot combine the Credit Card spend from multiple primary and supplementary Credit Cards to achieve the highest spend of the week.
8. The Cardholder will be notified of the bonus HSBC reward points earned via the respective Relationship Manager and the reward points will be reflected in the subsequent months' Credit Card statement of the Cardholder.
9. Only transactions posted on the particular week, during the Promotional Period, will be considered. Based on the Bank system records the winner will be selected on a weekly basis and such decision shall be final and conclusive. Bank shall not be held responsible for any transactions that are not posted, when selecting the highest spender of the week.

10. Following transactions shall not be considered under eligible transactions for the Promotion;
  - a. Fees and Charges as per Bank's Tariff and Charges and applicable tax,
  - b. Cash Advance, Balance Transfer, Cash Instalment Plan
  - c. Quasi transactions such as, but not limited to, Casino or Gambling transactions performed locally, overseas or on-line and crypto currency transactions.
  
11. In the event of any dispute regarding this Promotion, the decision of HSBC shall be final and conclusive.
  
12. HSBC reserves the right to modify any of the Terms and Conditions herein or terminate the Promotion at any given time at its absolute discretion.
  
13. The general HSBC Credit Card terms and conditions shall apply to this Promotion and for the usage of the Credit Card.
  
14. The Promotion cannot be exchanged for cash and/or used in conjunction with any other promotional programs of HSBC.
  
15. The Cardholder shall not hold HSBC responsible or liable for any loss or damage which the Cardholder may incur or suffer directly or indirectly arising out of or in connection with the Promotion due to any reason whatsoever.
  
16. Nothing herein amounts to a commitment or representation by HSBC to conduct similar promotions in the future.
  
17. These Terms and Conditions shall be construed in accordance with the laws of Sri Lanka and the exclusive jurisdiction to hear any disputes shall be vested with the Courts of Sri Lanka.
